#### 15.6 Local Government Act Review

Councillor Kolkman has given Notice in writing of his intention to move the following Motion at the next meeting of Council on 23 April 2013.

That Council make representations to Local Government NSW and the State Government with the intent of ensuring that, during the current review of Local Government and covered in Section 3.3.3 of 'A New Local Government Act for NSW', provisions be included to modify Clause 10 of the Standard Contract for Employment, and any relevant part of the Act, to require that:

- i. any move to summarily dismiss a General Manager must involve the General Manager being given at least 24 hours forewarning, in writing, of an intention of Council to move for dismissal
- ii. any move to terminate the contract of a General Manager must involve the General Manager being given at least five working days forewarning, in writing, of an intention to terminate the contract of employment
- iii. any decision to summarily dismiss or terminate the contract of a General Manager must involve the unrestricted publication of the grounds for dismissal or termination of the contract within one week of the decision
- iv. where a General Manager submits a written request (before or at the meeting where summary dismissal or contract termination is to be debated) that the reasons be kept confidential, such request may be acceded to by majority vote of the full Council.
