13. QUESTIONS WITHOUT NOTICE

13.1 Questions Without Notice

1. Councillor Kolkman referred to an email received by Councillors in relation to two local residents, selected to represent Australia at the Power Lifting Championships and seeking financial support and asked if this requests falls within Council's adopted policy.

The Director Community Services advised that the application has been received and is currently being processed.

2. Councillor Brticevic advised that he has received representations from a resident in Wyangala Crescent, Leumeah asking if consideration could be given to the relocation of the bus stop currently located outside 211 Wyangala Crescent as it is close to an intersection and impacts on safe traffic movement at this location.

The Director City Works advised that he would investigate the matter as requested.

3. Councillor Borg asked the General Manager if there is currently an avenue of trees in Koshigaya Park, Campbelltown honouring of those that have lost their lives in service of their country.

The General Manager advised that there is no such avenue within Koshigaya Park and he will investigate the possibility of an avenue of trees being established at an appropriate location and report back to Councillors.

4. Councillor Lake referred to an article in local papers regarding local fitness operators using Council open space to conduct their business.

The Director Community Services advised that as this issue is complex, Council Officers will provide detail of issues raised by residents and fitness providers at a future briefing evening for further discussion, prior to the presentation of a policy for adoption by Council.

5. Councillor Thompson referred to a property on the corner of Queen and Chamberlain Streets, Campbelltown noting that the fence around the property has not been fixed and asked if the Director Planning and Environment if he could advise as to what action can be taken to ensure the fence is fixed promptly.

The Director Planning and Environment advised that he will investigate the matter as requested.

6. Councillor Hawker asked to be provided with the status on the proposal to reopen the northern end of Brooks Road, Ingleburn, allowing access to the F5 on ramp.

The General Manager advised that he will investigate the current status of this proposal and advise Councillors of the outcome.

7. Councillor Brticevic noted that residents living on the northern end of Campbelltown Road, Denham Court have been letter boxed by the Roads and Maritime Services advising of a proposal to increase the number of lanes along this section from four to six lanes and asked if Director City Works if he was aware of this proposal.

The Director City Works advised that he is aware of the proposed road works in this vicinity and that he will be making a presentation outlining the proposal at a future briefing evening.

8. Councillor Oates referred to the large vacant block of land at the back of properties in Rudd Road, Leumeah and adjacent to the railway line that has recently been fenced. Councillor Oates asked the Director City Works if he could advise as to who is responsible for the ongoing maintenance of this site.

The Director City Works advised that the property in question is owned by the Department of Planning and that they will be responsible for the upkeep of the site and that he will contact them regarding their plans for ongoing maintenance.
