#### Background (16/10/2014)

Council resolved to undertake public consultation regarding a proposal to install BB lines at the bend of Chardonnay Avenue near Tununda Place, Eschol Park based on a previous report to the Local Traffic Committee.

Letters were sent to 8 residents in the vicinity of the proposed treatment with 3 residents responding. They supported the proposal but expressed concerns that the BB line was not significant enough to prevent motorists speeding through the bend, suggesting stronger traffic calming measures are considered.

Chardonnay Avenue is a narrow 8m wide local road with a 30m radius curve at its intersection with Tununda Place. Council's Technical Services has reviewed the BB line proposal and due to the narrow road, options are limited without hindering the movements of service vehicles at the intersection. It is suggested that the BB lines be enhanced with rumble bars in Chardonnay Avenue on both approaches to Tununda Place to discourage the speeding/loss of control behaviour of vehicles while at the same time not prohibit the movement of larger design vehicles. It has recently been reported to Council that a number of vehicles are now 'drifting' around the bend causing considerable disturbance to neighbouring residents.

It is further suggested that NSW Police be requested to undertake speed and driver behaviour checks in the street.

# Background (16/10/2014)

At its meeting of 14 August 2014 Council had presented a report to the Traffic Committee regarding changes to the existing parking arrangement on Ballantrae Drive near St Andrews Public School, to provide on street parking in front of St Andrews Children's Neighbourhood Centre to facilitate parents who want to pick up/drop off their children. The Committee had recommended that a review of the current parking be performed considering the relocation of part of the existing bus zone.

# Background (16/10/2014)

The Roads and Maritime Services has forwarded a B-Double Route application from SX Trailers of 26 Saggart Field Road, Minto to have the following route approved for 25/26m B-Double vehicles:

- 1. Ben Lomond Road, from Campbelltown Road to Cary Grove Road
- 2. Cary Grove Road, from Ben Lomond Road to Saggart Field Road and
- 3. Saggart Field Road, from Cary Grove to 26 Saggart Field Road

Although the above roads are in the Minto Industrial area they are not located within the approved Minto block area for B-Double routes gazetted by the Roads and Maritime Services.

Upon receipt of the initial application Council Officers contacted the transport company advising that there are likely to be issues with B-Double vehicles turning at three locations: the intersection of Cary Grove and Saggart Field Road, the right angle bend and end cul-de-sac of Saggart Field Road. Subsequently, the applicant engaged a consultant to conduct preliminary investigations especially in regards to the turning paths. The applicant has forwarded comments and preliminary plans of turning paths, which are summarised as follows:

- 1. The roundabout of Ben Lomond Road and Cary Grove is suitable provided B-Doubles uses both lanes of the roundabout.
- 2. The northern 15m of the central median in Cary Grove at its intersection with Saggart Field Road will need to be modified and replaced by a painted median to enable B-Doubles turn right and left at the intersection.
- 3. No Stopping kerbside parking restrictions will be required on Cary Grove ,Saggart Field Road and the turning circle at the cul-de-sac (refer to the attached plan)

In response Council Officers have reviewed these comments and in relation to the central median in point 2 above Council wishes to retain the central median to discourage corner cutting but would like the applicant to redesign the median to allow B-Doubles to manoeuvre over it.

To enable B-Doubles to use Saggart Field Road detail civil engineering plans will be required to determine the extent of adjustments required to the infrastructure and the positioning of No Stopping restrictions.

It is recommended to the Committee that at this stage Council undertake Community consultation with local businesses regarding the potential loss of kerb side parking and the matter be presented back to the Traffic Committee.

#### Background (16/10/2014)

The Campbelltown Traffic Committee at its meeting of 3 October 2013 received an application to assess Rose Street and Kialba Road, Campbelltown as a B-Double Route on behalf of F&A Scarcella Road Freight Transport. Following discussions, Council had some concerns about the turning paths that showed vehicles are likely to encroach over the double dividing barrier (BB) lines at this intersection. It was then recommended by the Traffic Committee that a trial run of the B-Double be carried out to see if the turns can be made in and out of Kialba Road.

The trial run was carried out on 15 September 2014 in the presence of Council Officers, Police and the Director of F&A Scarcella at the intersection of concern, to assess the movement and turning paths of the B-Double in and out of Kialba Road and Rose Street.

It was observed that the B-Double turned left into Kialba Road from Rose Street and right from Kialba Road into Rose Street without encroaching on the double dividing barrier (BB) lines. The B-Double was also successfully tested for its entry and exit into the property (lot no.21, belonging to the applicant) in the forward direction to ensure not to impede with any traffic on Kialba Road. It was observed that the B-Double successfully completed the movement in the forward direction (refer to attachment 2) in and out of the property.

It was advised by the applicant that there will be approximately ten trucks that would make freight deliveries per week using this route. As Kialba Road is a low volume trafficable road with only a few industrial lots, the number of trucks anticipated is not likely to disrupt the current traffic volume.

It was suggested by the Police representative that to further enhance the safety of road users at this intersection, the existing Give Way sign be replaced with a Stop sign (R1-1) and associated line markings.

It is recommended that the requested route for the B-Double be approved and the Roads and Maritime Services (RMS) be advised to publish the approval in the Gazette.

### Discussion (16/10/2014)

The Committee were advised that the Ingleburn RSL Sub-Branch have advised Council that they will be holding a Gala Day at Wood Park, Ingleburn on 8 November 2014 and have advised of a possible road blockage in Wagtail Crescent and Bowerbird Avenue due to an oversize vehicle.

There will be a display of military vehicles including an Armoured Personnel Carrier (APC) which will be delivered by a low loader. The low loader will have to remain in the vicinity of the APC and it is expected that the vehicle be parked in Wagtail Crescent.

The parking area at Wood Park will be used by military and historical units to display vehicles, motorcycles and military equipment.

# Purpose

To update Council on the community consultation process and outcomes that are planned to be undertaken to change some of Council's Shared Zones to High Pedestrian Activity Areas in Campbelltown adjacent to Campbelltown Mall and Ingleburn CBD's in Oxford Road (see plans attached).

# History

At its meeting of the 19 August 2014, Council resolved in principal that the concept of Shared Zones in the Campbelltown and Ingleburn CBD's could be substituted with the 40km/h High Pedestrian Activity areas. In addition, a Community Consultation process should proceed and the outcomes reported to Council.

# Report

A Community Consultation strategy has been developed and will commence in November 2014. The strategy will ensure that the community are informed through several communication methods giving ample time to comment on the consultation outcomes. #### Letters/Flyers

Letters and flyers will also be and distributed to local businesses within both of the CBD's by the Main Street Ambassador.

Through Council's website the community will be able to view the documentation as well as make comment on the proposal in a similar manner to how Council undertook the Community Consultation process associated with the Special Rate Variation and the Draft Campbelltown Local Environmental Plan 2014.

# **1.3 CCTV Network for Campbelltown and Ingleburn CBD - Update**

### Purpose

To update Council on the proposed CCTV Network for the Campbelltown and Ingleburn CBD's.

# History

On 9 September 2014, Council was advised that it was successful in receiving a grant to the value of \$350,000 from the Attorney General's Department. The grant was to be used to fund CCTV implementations in Campbelltown and Ingleburn Central Business Districts.

The provision of funding was conditional on Council completing the funding agreement which requires Council to meet agreed timeframes with regard to the completion of the project by May 2015

# Report

A number of meetings have been held with NSW Police and various sections within Council to determine the locations and hardware requirements for the CCTV system. Site walks have been undertaken and various sight lines reviewed within each of the centres to maximise the vision that can be achieved.

The initial data and project scoping has been completed and a consultant has been engaged to draw up the final specification and design for the system. This consultant will assist Council in all aspects of the project until the system is actually commissioned in February/March 2015. The initial system in both CBD's will monitor the main street with limited vision to the side streets. The cameras are wireless, and provide flexibility. The cameras can be moved to other locations within the CBD should the need arise.

The system design and specification that is being prepared will provide for growth of the CCTV system. The current system under consideration is a wireless solution. The cameras and system computers can be expanded for future optical fibre installation. The optical fibre will provide a faster higher quality image network with the capacity for increased camera installations.

Lighting within the CBD areas is also being reviewed as part of the project. The installation of an LED solution for these areas will provide a brighter white light which will assist both camera operation and general safety within the CBD.

A number of governance guideline documents are also being prepared for the operation of the system once in place. These documents will be presented to Council in early 2015 for consideration and endorsement.

# Report

Council at its meeting held 29 July 2014 resolved to undertake concept designs and cost estimates for a bridge and its approaches that would span Georges River at a location of 470m east of Appin Road and 235m west of the formalised section of Blackburn Road, Wedderburn.

To facilitate concept designs of the bridge and its approaches, Council contacted interested consultants to attend a preliminary site meeting on the 13 August 2014 to discuss the scope of work and provide a quotation for the concept design stage. The design stage included:

- timeframe for the concept design
- preliminary survey
- preliminary assessment of environmental impact
- hydraulic analysis
- preliminary consideration of noise and vibration impacts
- consultation with Mining and Subsidence Board
- heritage assessment
- concept options
- cost estimates
- final submission to Council.

After closure of the quotation process, seven consultants submitted proposals to Council. The quotations are currently under evaluation by the assessment panel and should be completed by November 2014. It is anticipated that the successful consultant will be awarded the contract prior to Christmas. After this process is completed it is expected that the successful consultant will take approximately twelve weeks to complete the concept designs and a report submitted to Council.

The next stage of this process will be identifying available funding sources and specifications for a tender process.

# Purpose

To update Council on the proposed concept design proposal for the Broughton Street Railway over/under bridge.

# History

Council at its meeting held 19 August 2014 resolved to undertake a concept design process for the Broughton Street Rail over/under bridge as part of the major works program.

# Report

As part of the recent traffic study of the Campbelltown Central Business District (CBD) the option of providing a connection over the rail corridor connecting Broughton Street to Badgally Road was examined.

The study identified that by providing this connection, the congestion experienced on Narellan Road at the Blaxland Road and Kellicar Road intersections and the Blaxland Road and Campbelltown Road intersection would be substantially reduced. The connection would also provide a valuable commercial connection between both sides of the railway line.

As part of this year's major works program, funding was identified to undertake a concept design of the bridge and surrounding road network. To do this expressions of interest are currently being prepared to engage a consultant to undertake the works.

It is proposed as part of this project that a Consultant be sourced to consider the following factors as identified below:-

- the appearance of the bridge
- is the connection better to be an over or under rail structure
- the impacts on the bus rail interchange and its possible future upgrade
- possibility of Hurley Street being lowered to the level of the interchange to pass under the rail connection
- access onto and off the road connection

- surrounding road connectivity to the structure and around the structure with particular focus on the CBD traffic loop created by Queen Street, Moore Oxley Bypass, Beverley Road and Broughton Street
- possibility for a bridge option being an integral part of the railway station complex with access to an over rail corridor parking area/pick up area
- review of how this connection will impact on the accessibility of the Blaxland Road commercial precinct
- review of how this connection will impact on the functioning of the CBD in general
- opportunities for a small retail/dining precinct focussed on servicing the needs of passengers in transit
- concept design of the final proposal options including cost estimate.

A project team is currently being established to finalise the brief and it is envisaged that the Expression of Interest will be released in late January 2015 with a final report to Council by June 2015.

As further developments transpire Council will be kept informed through a series of briefings.
