

15. NOTICE OF MOTION

15.1 Mental Health

Councillor Brticevic has given Notice in writing of his intention to move the following Motion at the next meeting of Council on 6 May 2014.

That Council write to former Councillor Jai Rowell, now Member for Wollondilly and Minister for Mental Health, Minister Assisting the Minister for Health and Party Whip:

- i. conveying Council's sincere congratulations on his recent promotion to positions with Baird Government Ministry that are of great relevance to the people of Macarthur.
- ii. drawing his attention to the fact that with the closure of the mental health facilities at the Campbelltown Private Hospital, demand for services formerly met there need to be picked up in the Waratah Mental Health Unit at Campbelltown Public Hospital. This requires the urgent dedication of Government funding to ensure the standard of mental health services in the Macarthur Region properly satisfy community needs.

15.2 Claymore Redevelopment

Councillor Kolkman has given Notice in writing of his intention to move the following Motion at the next meeting of Council on 6 May 2014.

1. That Council urgently write to the Hon Gabrielle Upton, the Minister with portfolio responsibility for Social Housing seeking:
 - i. an urgent recommencement of the redevelopment of Claymore, consistent with the scale of works originally planned
 - ii. the immediate allocation of all necessary funding to permit completion of the project without further delay
 - iii. the immediate resumption of funding to facilitate the urgent recommencement of maintenance of tenanted housing to alleviate the virtually third world conditions confronting some residents.
2. That Council urgently write to the Members for Camden and Campbelltown urging them to join forces to actively and strenuously lobby on behalf of the community of Claymore with the specific aim of encouraging the NSW Government, of which they are a part, to achieve the long planned redevelopment of the community of Claymore without further delay.
