# **16. NOTICE OF MOTION**

## **16.1 Audio Recording of Council Meetings**

- 1. Whether the following councils offer recordings of their meetings online and in what cases, also live streams?
  - Lane Cove Shellharbour Wollongong Newcastle Hornsby Clarence Valley Mid Western Regional Kiama Warringah
- 2. Whether any other NSW councils offer recordings of the meetings online and in what cases, also live streams.
- 3. Whether there has been any defamation action successfully actioned against a council or councillor due to audio recordings (not live streams) being made available online since the 2006 defamation reforms, and if so, what was the total damages awarded.
- 4. Detail the implementation of a system where council meetings are recorded, reviewed for any potentially defamatory material to be removed on the approval of the general manager, and then released on the council website.
