## **Purpose**

To inform Council of Parklands Early Learning Centre's participation in a trial of the new assessment and ratings process for the implementation of the National Quality Standard.

## **History**

Council at the meeting of 6 April 2010, Community Services Committee was advised of the NSW Government Council of Australian Governments (COAG) reforms for child care services.

In December 2009, COAG signed the National Partnership Agreement on the National Quality Agenda for Early Childhood Eduction and Care. This new framework will deliver better quality services and promote good educational and social outcomes for more than one million children attending long day care, family day care, outside school hours care and preschool.

Under this agreement, COAG endorsed a National Quality Framework for early childhood education and care and outside school hours care services. The National Quality Framework will replace separate licensing systems in each State and Territory with a unified national system, with a set of national quality standards, which will be implemented by 1 January 2012. This new national approach will replace the current licensing and accreditation processes undertaken by States and the Commonwealth. Individual services will now only deal with one organisation for quality assessment, reducing the regulatory burden.

## Report

The National Partnership Agreement provides that the National Quality Standard will be subject to field testing and targeted consultation prior to finalisation. The refinement of the assessment and ratings tool will be ongoing until the end of 2010. This will be followed by a further rollout across a number of services over subsequent months. The purpose is to make sure the Government has a rigorous assessment and ratings tool for formal implementation on 1 January 2012. It is expected that some changes to the assessment and ratings tool will be needed to ensure that it is consistent with the final content of the legislation underpinning the National Quality Standard. The Act and Regulation for the National Quality Standard will be finalised later this year. It is intended that the assessment and ratings tool will be finalised in early 2011 which will allow for the further development of guidelines and a range of other resources to enable training development to commence from July 2011.

Twenty one child care services from across Australia were selected to participate in a trial of the new assessment and ratings process for the implementation of the National Quality Framework.

Council's Parklands Early Learning Centre was included in the trial as one of only two child care centres selected from New South Wales. The centre received a draft guide to the National Quality Standards and has completed a self assessment and quality improvement plan, which includes the assessment and rating tool that assessors will review before they visit the service to conduct the assessment in June 2010.

Following the visit from the assessment team, comprising of a validator from the National Childcare Accreditation Council and a State and Territory licensing officer, Council will be asked to provide feedback on the draft assessment and ratings process, including the report on our provisional rating. This feedback will be extremely valuable as it will inform of improvements and refinements to the assessment and ratings process. There will also be opportunities to debrief, share experiences and provide feedback.

Participation in the assessment process will provide valuable information about the National Quality Standards and Council's performance against each of the Standards for use by the services, as well as providing valuable information and suggestions to further improve and refine the assessment and ratings process.

## 2.3 Midnight Basketball Tournament 3 Evaluation

## **Purpose**

To provide Council with an evaluation report on the Midnight Basketball Tournament 3 held on Friday nights over eight weeks from 5 February to 26 March 2010.

## **History**

Midnight Basketball is a program that focuses on crime reduction through a combination of life skills education and competitive basketball. At the core of the concept is the notion of life skills education of young people through carefully designed and delivered workshops. Each night, in order to play, participants must attend a workshop dealing with topics such as drugs and alcohol, getting a job, staying healthy and anger management. The slogan "**No Workshop, No Jumpshot**" is used.

Council at its meeting of 9 February 2010 considered an evaluation report on the Midnight Basketball Tournament 2 held over eight weeks from 23 October – 11 December 2009.

## Report

Campbelltown's third Midnight Basketball program followed on from the success of Tournaments 1 and 2, with an overwhelmingly positive response received from the community, shown by an increasing number of player registrations, volunteers and spectators attending each night.

#### Registrations

As with Tournament 1 and 2, registrations for the tournament were capped due to the large number of registrations initially received, as the venue was only able to cater for 60 players, remaining registrations were placed on a waiting list for the fourth tournament.

The program has attracted local young people from a variety of cultural backgrounds and geographical areas within the Local Government Area. Participants were put into teams for the tournament, allowing them to interact in a positive environment with a range of other young people who they may not have had contact with previously.

#### **Community partners**

A number of community organisations were involved with the development and implementation of the program, including the YMCA, Youth Solutions, Communities NSW: Sport and Recreation, Commonwealth Bank, Housing NSW, Uniting Care Burnside, Campbelltown Youth Services, Interline Bus Services, Working Together in Minto, PCYC, Traxside, The Junction Works, Volunteering Macarthur, South West Youth Peer Education, NSW City Rail, University of Western Sydney and the YWCA's Yummy Café.

Due to the success of previous tournaments, the number and level of support of community partners has increased significantly for Tournament 3. All partner agencies have committed to their continued involvement in Midnight Basketball during 2010. Several larger organisations are also showing interest in contributing to the project, which is working towards a well resourced and sustainable model of Midnight Basketball throughout 2010 and into the future.

#### Volunteers

Council received 29 volunteer registrations from community members for Tournament 3. On average 25 volunteers assisted each night of the tournament. Volunteers assisted with the program in a number of roles including team managers, scorers, score board operators, catering assistance, workshop assistance, bus assistants and general event assistance.

Volunteers came from a number of sources including local high schools, youth organisations, Housing NSW, Campbelltown City Council, Commonwealth Bank, The Junction Works as well as interested community members. Feedback from the volunteers on their experiences working with young people in the program was very positive.

The program averaged 40 spectators per night, with the largest turnout of 70 spectators on Grand Final night. Some of the players' parents formally volunteered for the program, whilst others spontaneously assisted on some nights of the program.

The high level of community participation in the program contributed to the success of the tournament. This enhanced the experience for the players by providing positive role models from the local community.

#### Workshop program

Participants attended compulsory life skills workshops over the 8 week period. Workshops covered a range of areas including nutrition, team building and rule setting, drugs and alcohol, employment and career pathways, leadership and cultural diversity, self esteem and the importance of working in a team.

#### Funding

Tournament 3 was supported by contributions from Midnight Basketball Australia, Housing NSW and the University of Western Sydney, as well as significant in-kind support from partner organisations. Future tournaments will be funded through a combination of government grants, Midnight Basketball Australia funding and local sponsorship, in addition to in-kind support from project partners.

#### **Evaluation**

At the conclusion of Tournament 3 evaluations from players, volunteers and partner organisations were conducted and the results collated by an external research body. Feedback from 56 players was extremely positive, with over 98% of participants rating the program as very high and commenting that they felt safe whilst at Midnight Basketball.

Certificates of Appreciation have been forwarded to participating players, volunteers and partner organisations.

## **Purpose**

To seek Council's endorsement of a submission to the Federal Government through the Australia Council for the Arts requesting \$10,000 from the International Visitor's Program to support the invitation of internationally renowned artist Krzysztof Wodiczko to visit Australia in 2011.

## Report

Campbelltown Arts Centre continues to seek opportunities to engage local communities and audiences with Australian and international artists whose work explores ideas, issues and themes that illuminate and are pertinent to the lives and experiences of local audiences and residents.

The Campbelltown Arts Centre, in partnership with the cultural institution IASKA in Perth and the Centre for Ideas, University of Melbourne, seeks to invite the internationally renowned artist Krzysztof Wodiczko to undertake a visit to Sydney, Perth and Melbourne in 2011 as part of the Australia Council for the Arts International Visitors Program. The primary purpose of the proposed visit by Wodiczko is to invite the artist to develop a scope for a new major community engaged project that would be co-commissioned by the Campbelltown Arts Centre and IASKA, Perth. It is envisaged that this project (or series of separate projects) would be presented as site-specific public works in Western Sydney and Western Australia.

Krzysztof Wodiczko (b.1943, Warsaw, Poland) has been creating site-specific image and video projections both within galleries and using architectural façades and monuments as backdrops for nearly thirty years. These politically-charged works of art, which have been shown in over a dozen countries around the world, speak to issues of human rights, democracy and alienation using sound and motion often include testimonies of the people whose plights they address. Krzystof Wodiczko represented Poland in the 2009 Venice Biennale and is a much sought after artist who rarely commits to major projects. His agreement to begin discussions regarding a new work in Australia is a very significant achievement for Campbelltown.

The grant submission to the Australia Council would cover artist fees and all associated travel expenses for Krzysztof Wodiczko's work both in Western Sydney and in Western Australia proposed for 2011. No additional resources would be required by Council.

## 7.1 Cultural Services Manager's Report

#### **Purpose**

To inform the Campbelltown Arts Centre Advisory Committee of the recent achievements and outcomes of the Cultural Services Manager.

#### Report

#### 2010 NSW Local Government Awards

The NSW Local Government Cultural Awards recognise best practice management and innovation in cultural development within NSW Local Governments. The Award winners were announced on the evening of 29 April 2010 at Parliament House.

The Campbelltown Arts Centre won a 2010 Local Government Cultural Award under the category of 'Program, Projects and Partnerships'. This category recognises leadership by Local Government in developing, undertaking or commissioning cultural programs that address community need and was the most competitive category of the Awards.

The Campbelltown Arts Centre won for project *The Riot Act* - a new Australian theatre work devised and directed by Karen Therese and produced and presented by Campbelltown Arts Centre that investigated forces and opinions that shaped communities experiencing social unrest. Inspired by newspaper headlines that followed three highly publicised riots in NSW including Bidwell, Redfern and Macquarie Fields, The Riot Act observed how the media represented communities.

#### Australia Council for the Arts - Multi Arts Status

Australia Council for the Arts approved an application by Campbelltown Arts Centre for 'multi-arts status' in 2009 allowing the submission of grants under a range of programs including music, dance, visual arts and new media.

Since opening in 2005 Campbelltown Arts Centre has demonstrated a history of service towards the presentation, creation, development, support and service of arts activity in more than one definable artform. Approval of 'Multi-arts Status' by the Australia Council for the Arts, ensures that Campbelltown Arts Centre is able to submit up to five grant applications per year – an increase from two applications per year. This significantly assists the Centre in program development and delivery by ensuring that external resources to the Centre continue to develop.

#### SITELab Funding – Minto Arts Program

Campbelltown Arts Centre has received \$20,000 from Australia Council for the Arts, Interarts Program to assist in the delivery of 'SITELab', a contemporary cross-art form project developed with the communities of Campbelltown and Minto. The Australia Council's - Interarts Program supports artists investigating new artistic practice through interdisciplinary, hybrid and multimedia arts. This program is focused on the development of new work that encourages audience participation and interaction particularly through live performance, multidisciplinary arts practices and the use of new technologies.

SITELab is a series of collaborative performance works developed in partnership with communities in Minto. This program will be integrated into the overall Minto Arts Program that is aimed at developing and implementing arts programs that make a strong contribution to developing cohesive communities in Minto. The Minto Arts Program will also form an important part of the broader One Minto Plan. The success of this grant application demonstrates Campbelltown Arts Centre's exceptional achievement in delivering significant community cultural development projects in partnership with its local communities and State and Federal Government organisations.

#### Black2Blak3 - NSW Aboriginal Visual Arts Conference

Black2Blak3 is the third of three conferences that examine and profile Aboriginal visual arts practice in NSW. The conference will examine key issues currently being faced by Aboriginal visual artists and arts professionals in NSW. The conference will be held at Campbelltown Arts Centre on the 22 – 23 May. Speakers involved in the program include Gary Foley, Fiona Foley, Gary Lee, Bronwyn Bancroft and John Maynard along with artists and arts workers from across NSW.

The ABC's Radio National program Awaye will broadcast the proceedings nationally, which will be published in a hard copy format illustrated with images of NSW Aboriginal art and others content generated from the discussion. This conference series continues to contribute to positioning Campbelltown as a leader in Aboriginal arts development in NSW. \$15,000 in bursaries is being provided by the NSW Government through Arts NSW to provide travel and accommodation support for Aboriginal artists from regional NSW to travel to Campbelltown for the duration of the conference. Campbelltown Arts Centre will manage and administer the bursaries to the artists.

#### Public Art Project – Campbelltown Railway Station Interchange

Campbelltown Arts Centre has commissioned the Aboriginal artist Jason Wing to develop a series of portraits of senior members of the Aboriginal community that will be installed on the billboard panels at Campbelltown Railway Station. Jason Wing was born in Sydney in 1970 and is a Western Sydney-based artist. Since graduating with a Bachelor of Fine Arts at Sydney's College of Fine Arts in 1998, Wing has steadily emerged in the Sydney and national art scene as a versatile artist who explores issues of bi-cultural and Indigenous identity, environmental awareness and spirituality.

Jason Wing will work with the photographic portrait series by Mervyn Bishop of forty members of Aboriginal seniors in Campbelltown. This series of photographs were commissioned for the Campbelltown Aboriginal Intergenerational project and resulted in the award winning publications, Tell Me My Mother and My Father My Brother. These photographic portraits will be transformed in large scale paintings in consultation and collaboration with the participants in the project.

The work will be developed at Campbelltown Arts Centre over the next six months and installed at Campbelltown Railway Station at the end of the year. The Campbelltown Arts Centre is working in collaboration with City Works who will construct and install the panels. The project is being funded through existing City Works Budgets. The NSW Government through Arts NSW has agreed to contribute \$15,000 towards the project towards artists' fees.

#### More Than My Skin - National Exhibition Tour

Campbelltown Arts Centre has submitted an application to the Federal Government through Visions of Australia requesting \$80,000 support from Visions of Australia, Australian Touring Exhibition funding program for the national tour of *More Than My Skin*. Visions of Australia, Australian Touring Exhibition funding program provide organisations with funding to develop and tour exhibitions of Australian cultural material throughout Australia. Funding is available for both development and touring costs.

Campbelltown Arts Centre has developed a national travelling exhibition titled *More Than My Skin*. In 2009, this exhibition toured throughout the Northern Territory for a six month period and was seen by more than three-thousand visitors. Due to the success of this tour, Campbelltown Arts Centre will now embark on a national tour of this exhibition commencing in September 2010.

More Than My Skin is an exhibition that brings together the work of six of Australia's leading Aboriginal photographers; Michael Aird, Mervyn Bishop, Gary Lee, Ricky Maynard, Peter McKenzie and Michael Riley. The exhibition examines issues facing Aboriginal males and how Aboriginal masculinity has been constructed in recent times. The national tour of More Than My Skin will be accompanied by a publication and education program. The national tour of this exhibition will consolidate Campbelltown Arts Centre's reputation as a Centre that support contemporary Aboriginal arts development and expand the Centre's profile for developing and producing innovative exhibition programs.

#### Shaun Gladwell - Venice Biennale Exhibition

Shaun Gladwell has recently presented his Venice Biennale Commission at Campbelltown Arts Centre from 27 March – 16 May 2010. In 2005 Campbelltown Arts Centre commissioned Shaun Gladwell to produce a new work for the Centre's inaugural exhibition *C'town Bling*. The resulting video captured two local youths knee-sliding down a rain soaked surface at Campbelltown Skate Park. The work spoke eloquently of and to the community it represented, including the artist himself - a fellow skater raised in western Sydney.

In the five years following, Shaun Gladwell has emerged as one of Australia's most important and internationally recognised contemporary artists. Since 2007 Gladwell has been working on an ambitious and ongoing body of work that has seen him move his focus from urban environments to the Australian outback. This body of work has marked the maturity of Gladwell as an artist, recognised by its selection for the Australian Pavilion at the 53rd Venice Biennale 2009, arguably the world's most important contemporary art event. Notably, this exhibition is the first time Gladwell's acclaimed Venice Biennale presentation will be shown in Australia. Interior Linework/Interceptor Intersection is an exciting project that reflects Campbelltown Art Centre's commitment to providing its communities with the opportunity to experience and access the most innovative and highest standard of contemporary art.

#### **Once Removed - Venice Biennale Exhibition**

Once Removed will be presented at Campbelltown Arts Centre from 29 May to 1 August 2010. Once Removed was commissioned by the Australia Council for the Arts as a special project for the 53<sup>rd</sup> Venice Biennale in 2009. The exhibition has been curated by Felicity Fenner and features three large-scale installation works by the artists Claire Healy and Sean Cordeiro, Vernon Ah Kee and Ken Yonetani. Once Removed follows the highly successful exhibition of Shaun Gladwell's work, Interior Linework / Interceptor Intersection which was also commissioned by the Australia Council for the Arts for the Venice Biennale for Australian representation at the Australian Pavilion.

#### Jagath Dheerasekara Exhibition

Jagath Dheerasekara was born in Sri Lanka and arrived to Australia in 2008, settling in Bradbury, Campbelltown. His work has been exhibited internationally in several countries including Austria, India, United Kingdom and Sri Lanka. This includes exhibitions such as the Royal Photographic Society of UK, Hasselblad Austrian Super Circuit, Maitland International, Sydney International and Southampton International. The most recent being the Chobi Mela V – International Festival of Photography, Bangladesh, 2009. Jagath Dheerasekara's work was presented at Campbelltown Arts Centre from 30 March – 30 April 2010.

#### **Intercultural Dance Project Residency**

The 2009 Intercultural Dance Project Commission of Sydney-based dance artists Kathy Cogill and Latai Taumoepeau continued to Stage Two, with the addition of photographer/visual artist Greg Semu, a Samoan artist based in Paris, joining the creative team. The addition of a third artist, for the second stage helped to recontextualise the work of Cogill and Taumoepeau within a broader cultural and international framework. Stage Two of the Intercultural Dance Project provided the opportunity for new directions of thought and inquiry for dance as an art form, resulting in the production of a Video Work for gallery presentation. On Thursday 4 March 7.30pm an informal showing was presented, attended by a mix of artists and academics with an interest in cross-cultural issues. The discussion following the showing was rigorous and generated some interesting questions for the project artists to carry forward to the third and final stage scheduled for 2011.

#### **Driven to New Pastures – Minto Performance Work**

In July 2009, Rosie Dennis was an artist in residence at the Minto Community Hub for 4 weeks. During this time she joined the Minto Mob walking group, attended local residential committee meetings, had afternoon and morning teas with local residents and attended community lunches. The first local resident to invite her for morning tea was 74 year old June Hickey. June is one of a handful of public housing residents living in Minto who will not be relocated. June and Rosie met every week at the walking group. At the end of Rosie Dennis' 4 week residency, Rosie and June kept in touch - talking weekly and visiting fortnightly. After a few months, Rosie invited June to be part of a new performance work that would tell her story.

June hasn't performed since a primary school play in Bathurst. She has lived in Minto for more than 32 years. Driven to New Pastures tells a universal story about suburban redevelopment, community, belonging, the importance of neighbours and the significance of home. It is an intimate show that was performed in an old church (St James Anglican Church) that was built in 1897. The church was originally in Ingleburn and was moved - brick by brick - in 1918 to Minto.

Afternoon and morning teas played an important role in Rosie and June's friendship. For this reason they have decided to offer audiences a cuppa and a piece of apple tea cake when they come along to the show essentially they are inviting people along for a 'story' and afternoon tea or supper. This performance was presented to much acclaim in Minto with overwhelmingly positive feedback from local residents.

## **Etiquette Performance**

During 2010 Campbelltown Arts Centre is expanding its program of live performance to include a range of works that push at the boundary of contemporary performance and actively engage with audiences, location and site. The first work to be presented as part of the Live Program is Etiquette by innovative UK-based Company Rotozaza. It was performed in the café at the Arts Centre from 19 April until 2 May. Etiquette is a 30-minute live experience for two people who simultaneously play the roles of performer and audience in the Campbelltown Arts Centre's Cafe. Etiquette will quite literally draw you into a gripping and highly personal performance. Taking a seat with a friend or stranger, and using separate headphones, you follow instructions and act out the performance together, inhabiting roles in a series of short scenes, many borrowed from film and theatre.

This fascinating show opened in London in 2007 and has been performed around the world, including Australia, Canada and Spain. Rotozaza are based in London and Brighton, UK. The writer and director Ant Hampton formed Rotozaza in 1998 and joined with performer Silvia Mercuriali shortly afterwards to make the second show [DUE] in Milan, Italy, 1999. They have been working together in different ways and in various countries and languages on over 20 Rotozaza productions. Since 2003 the work has involved particularly close collaborations with Neil Bennun, Greg McLaren and Melanie Wilson. This project was supported by the British Council.

#### **Seniors Week**

On 21 March the Arts Centre held its annual Seniors Tea Dance as part of Seniors Week. The dance was attended by approximately 70 seniors and held in the Campbelltown Arts Centre performance studio. The Tea Dance received support through the Department of Ageing, Disability and Home Care. Now in its 52nd year, Seniors Week is held each year to celebrate and thank senior citizens of NSW for the valuable contribution they make to our State. The Tea Dance included a live band The Penguins as well as a special performance by the MC for the event, Glenn Wood.

Also as part of Seniors Week, Uncle Whatever's Soiree for Seniors gave the opportunity for 12 local seniors to perform to a live audience. Some participants had not had previous performance experience whilst others were professional performers. Performances included dances, skits, readings, comedy, singing and music. The event was at full capacity, attending by 40 people in the Campbelltown Arts Centre rehearsal studio. The event received support through the Department of Ageing, Disability and Home Care.

As part of Seniors Week Campbelltown Arts Centre also hosted a number of workshops specifically directed towards seniors, including an embroidery masterclass and a quilting masterclass, and a walking tour through the historic sites of Campbelltown including an exhibition tour of the Arts Centre.

#### Youth Week

Campbelltown Arts Centre commissioned artist Linda Luke, together with video artist Sean Bacon and sound artist Vic McEwan, to produce a dance based film Dance Diaries as part of Youth Week. Three young people were engaged in performance development workshops for three full days in the lead up filming. The project was filmed off site in locations across Campbelltown over two full days as a solo film project. The project is currently being finalised and will be completed in June.

Campbelltown Arts Centre also held a number of school holiday workshops directed towards teenagers as part of Youth Week, as listed above. 13 young disadvantaged young people received subsidized enrolments in the Hip Hop workshop and 4 young people in the Film Making workshop through a partnership agreement between Campbelltown Arts Centre and the Pacific Council.

## **Heritage Week**

To celebrate Heritage Week in 2010 Campbelltown Arts Centre hosted the Annual Heritage Forum on 15 April 2010. The theme of this year's forum was 'The Making of Our Nation' and centred on the anniversary of the appointment of Governor Lachlan Macquarie. The forum included a keynote speech by Dr James Broadbent, as well as the awarding of the annual Heritage Medallion. In 2010 four medallions were awarded. Campbelltown Arts Centre also launched a commissioned film as part of the forum. The forum was attended by approximately 90 people.

Campbelltown Arts Centre commissioned Angelica Mesiti to produce a film inspired by the influence of Governor Lachlan Macquarie on the region of Campbelltown. 19 high school students from Broughton Anglican College were involved in the making of the film, which was based around a classical music piece performed by the students at Glen Alpine Heritage Reserve, filmed over one full day, following a series of rehearsals and performance development exercises held at the school.

## Report

MINTO: LIVE is a site-specific performance event that will be presented in Minto in partnership with the communities of Minto. During January 2011, MINTO: LIVE will run parallel to Campbelltown Arts Centre's Edge of Elsewhere project. The project will commission four local performance works and four international performance works that will be presented as a three-day event in Minto. Each of the eight works will engage and reflect the experiences of cross-cultural exchange within Minto communities.

MINTO: LIVE will be presented in the form of a tour, with local volunteer tour-guides who accompany the audience through the neighbourhood. It offers audiences an exceptional range of opportunities to experience newly commissioned performance works across Minto. The program will invite the communities living in the local area to be more than audience – to be part of the 'scene' and contribute in the making/realising of the work. Each of the eight works will engage and reflect the experiences of cross-cultural exchange with the new and established residents in the local area. These performance events will provide audiences with a unique inter-cultural experience using performance, song, dance, multi-media installations and visual arts.

MINTO: LIVE will build upon Campbelltown Arts Centre's established links to Aboriginal and diverse communities across Sydney's South West, and will build upon interdisciplinary priorities from a range of disciplines across community practices and Government Departments.

This program further demonstrates Campbelltown City Council's ongoing commitment to the overall Minto Arts Program that is aimed at developing and implementing arts programs that make a strong contribution to developing cohesive communities in Minto. The Minto Arts Program also forms an important part of the broader One Minto Plan.

The partners in the delivery of MINTO: LIVE include Sydney Festival, British Council, Arts NSW, Australia Council for the Arts, Dance 4 UK, Belguim Consulate and Minto Anglican Church. Campbelltown Arts Centre is currently seeking further funding from external organisations including Working Together in Minto (Housing NSW) and Landcom.

## 8.3 Grant programs by Communities NSW, Sport and Recreation

#### **Purpose**

To inform the Sports Liaison Sub Committee of the new grants programs being made available for sport and recreation purposes by Communities NSW, Sport and Recreation (formerly the NSW Department of Sport and Recreation).

#### History

Historically, the NSW Department of Sport and Recreation has administered the Capital Assistance and Regional Facility Grant programs each year, of which Council has been extremely successful in securing funding for sporting facility improvements.

A review has recently been conducted by the NSW Government into sport and recreation funding and changes have been made to consolidate their multiple grants programs.

#### Report

The Sport and Recreation Facility Grant program replaces the previous Capital Assistance and Regional Facility Programs and opened in December 2009. Application closed on 2 March 2010.

The Sport and Athlete Development Grant is aimed at State Sporting Organisations.

The Sport and Recreation Facility Grant program is open to incorporated community based notfor-profit organisations and Local Government Authorities. Grants up to \$200,000.00 are available to organisations for projects that will meet one or more of the following objectives:

- Increase regular and on-going participation opportunities in sport, recreation or structured physical activity in a sustainable manner;
- Improve access for people from groups that traditionally find it difficult to access sport;
- Improve safety at sport and recreation facilities;
- To develop environmentally sustainable sport and recreation facilities;
- Assist people from identified groups that face barriers to participating in sport and recreation.

The total cost of all projects is \$866,000. The commitment of Council funds to the above projects totals \$220,500.

Council Officers have been liaising with Communities NSW, formerly NSW Department of Sport and Recreation, regarding their Sport Education Programs that are designed to assist and develop sporting clubs and associations.

The majority of clubs in Campbelltown are involved in winter sport therefore it is planned to concentrate the programs around January, February and March in preparation for the 2010 winter season.

As part of this collaboration local Pacific Community members also performed at the exhibition opening on 15<sup>th</sup> January 2010.
