Thank you for your correspondence regarding the new commuter car park at Macarthur Station.

The 'Macarthur 2' Commuter Car Park Project is being delivered by the Transport Construction Authority (the Authority) on behalf of the NSW Government. As outlined in previous correspondence to Campbelltown City Council on 27 April 2010, several options for the location of 'Macarthur 2' were considered during the early planning phase for the Project.

Three feasible options for commuter car parking were progressed for further detailed assessment as part of the Review of Environmental Factors (REF) process leading to the preferred option being selected.

I am advised that sites to the northern side of the railway line were considered unsuitable for a commuter car park based on previous studies, planning approvals, and government agency decisions which committed bus interchange facilities to the other side of the railway to create a transport hub. This information is outlined in the *Macarthur 2 Commuter Car Park Determination Report* which is available at the Authority's website at www.tca.nsw.gov.au.

The northern side of the railway was also determined to be an unsuitable site because it lacked the required infrastructure, including roads, and because of existing zoning issues, the likelihood of flooding, and the cost of necessary site preparation works.

I am further advised that a number of studies have previously investigated the master planning of Macarthur transport interchange, including Macarthur Transport Interchange Study (Maunsell 2003 for RailCorp); Macarthur Bus Interchange Report (Design Inc 2004); Bus Access to Macarthur Transport Interchange and Regional Centre (PB for the NSW Department of Planning and the Department of Natural Resources May 2005) and Bus/Rail Interchange Options Development Report (Maunsell 2007 for RailCorp). These reports are also referenced in the Macarthur 2 Commuter Car Park Determination Report.

These previous studies assessed the associated matters of access to the Station, environmental considerations, infrastructure building costs, the availability of land for the proposed land use, and strategic long term planning for the region.

The Project's Planning Approval documents were on public display between 6 October and 27 October 2009, and written submissions were invited from the community at this time. Following careful review of all submissions the Project was approved in December 2009. Construction of the new commuter car park commenced in March 2010 and is scheduled for completion in 2010.

I trust this information is of assistance.

#### Macarthur Station Interchange - Proposed Car Park (Macarthur 2)

I refer to the above matter and advise that Council at its meeting of 1 June 2010 considered a response provided by the former Minister for Transport and Roads, the Honourable David Campbell, on the location of the car park currently under construction in close proximity to the Macarthur Gardens Estate.

It was resolved at the meeting that Council write to the Minister for Transport outlining the concerns raised with the previous Minister as follows:

- (a) Has a report been commissioned to assess the option of constructing a commuter car park for Macarthur Station on the University of Western Sydney Campbelltown Campus side of the Station?
- (b) If so,
  - (i) What is the name of the Report?
  - (ii) When was it commissioned?
  - (iii) Why has it not been released to the public?
- (c) If not, why has the Member for Wollondilly told Macarthur Gardens residents that the option of constructing a commuter car park for Macarthur Station on the University of Western Sydney Campbelltown Campus side of the station has been assessed?
- (d) What other reports, if any, have been commissioned to assess alternate options for the car park closer to the train station and;
- (e) If so,
  - (i) What is the name of the Report?
  - (ii) When was it commissioned?

- (f) Request that they adopt an appropriate measure of consultation and discussion with the community prior to any construction.
- (g) Inform the Minister for Regional Development, the Honourable Phil Costa and the Minister for Planning, the Honourable Kristina Keneally, that Council is opposed to a car park so far away from the train station.

Your response to these questions would be appreciated.

Council notes that the Honourable Kristina Keneally is now the State Premier and that the Minister for Planning is now the Honourable Tony Kelly MLC.
