I refer to your representations on behalf of Mr Paul Tosi, the General Manager of Campbelltown City Council, concerning state-wide planning controls for boarding house development.

The Department of Planning and Infrastructure has offered to meet with Council staff to discuss options for a local planning solution for boarding house development. The Department is hopeful that a solution can be devised which will continue to allow boarding house development that helps meet the needs of the area, in the right locations. If such a solution can be identified, consideration can then be given to an exemption for Campbelltown LGA from the broader state-wide boarding house provisions of the *State Environmental Planning Policy (Affordable Rental Housing) 2009* (the AHSEPP) and the *Standard Instrument – Principal Local Environmental Plan*.

This approach is consistent with the Government's broader aim of enabling councils to encourage the development of affordable housing of a scale and type consistent with Council objectives.

The Department has also invited Council officers to contribute to a broader discussion on the review of boarding house policy. This forms a part of targeted stakeholder consultation being carried out to help inform a review of planning controls relating to boarding houses in the AHSEPP.
