Dear Mr Sewell

Thank you for your correspondence to South Western Sydney & Sydney Public Health Unit, regarding smoking in spectator areas at sporting grounds and other recreational areas. Dr Susanne Benjamin, Acting Director Public Health has asked me to respond. I apologise for the delayed response.

In relation to your question about spectator areas, the *Smoke-free Environment Act 2000* requires all spectator areas to be smoke-free. A 'spectator area' is defined in the Act as 'an area set aside for or being used by spectators to watch an organised sporting event at a sports ground or other recreational area'. The Act does not prohibit smoking at outdoor events such as concerts, other public events or gatherings organised at sporting grounds or recreational areas. However this does not preclude event organisers from implementing their own smoke-free policies for such outdoor events.

The NSW Government is committed to reducing smoking rates and community exposure to second-hand smoke and tobacco-related harm. The smoke-free areas covered by the *Smoke-free Environment Act 2000* were selected based on a number of sources of evidence relating to research on the health effects of outdoor smoke and tobacco control measures of other jurisdictions.

NSW Health is responsible for the administration and enforcement of the *Smoke-free Environment Act 2000* and NSW Health Inspectors are authorised to enforce these bans. While local clubs are encouraged to support the bans, they are not responsible for their enforcement or for non-compliance by individuals while on their grounds.

The NSW Ministry of Health has a comprehensive state-wide education campaign in place to ensure a high level of community and business awareness and compliance with the new laws. NSW Health is also working with NSW Sport and Recreation to target key industry stakeholders such as state sporting organisations and major sporting venues to increase awareness of and compliance with the provisions of the Smoke-free Environment Act 2000.

RE: Smoke free legislative reforms - outdoor public places

I refer to written notification of the above matter received from Dr Kerry Chant, Chief Health Officer and Deputy Director-General Population and Public Health dated 22 November 2012 advising of the introduction of the abovementioned smoke-free reforms.

I advise that Council considered a report on this matter at its Ordinary Meeting on 18 December 2012. As part of its report deliberations, Council wished to seek further clarification in respect of outdoor smoking bans as they apply to spectator areas at public sports grounds and other recreational areas.

Council noted advice that indicated smoking is banned in spectator areas (both covered and uncovered) at public sports grounds and other recreational areas, however only when organised sporting events are being held. This advice was based primarily on information contained within the NSW Health fact sheet relating to smoking bans in spectator areas at public sports grounds.

In view of the above, Council seeks clarification from the NSW Ministry of Health that the bans in respect of spectator areas at public sports grounds and other recreational areas only apply during sporting events and do not extend to other public events or gatherings upon sports grounds or recreational areas.

Furthermore, if your advice maintains that the ban does not extend to events other than of a sporting nature, it would be appreciated if you would be able to provide an explanation as to why public gatherings for other events have not been incorporated into the outdoor smoking reforms.
